Rising water during event	Paddlers, spectators, public	3	3	<p>Organiser will: Inspect and continue to monitor how fast the water levels are rising. The starter and finisher should be able to notify of any sudden increase in water levels since as they are on the waters edge so would have to move in the event of sudden water level rises. Any anticipated water level changes will be communicated to all paddlers at the event briefing.</p>
Being struck by moving vehicles in the car park / campsite	Paddlers, event volunteers, spectators, public	2	3	<p>Traffic moving around the site to be at low speed 10 MPH as signed</p> <p>Parking to be arranged to ensure emergency vehicles can access the campsite if needed.</p>
Slips, Trips, Falls	Paddlers, event volunteers, spectators	3	4	<p>Event information to advise paddlers to beware of uneven surfaces and wet steps. Signage will be provided at the foot of the steps leading to the riverbank reminding users that the riverbank is uneven and may become slippery when wet.</p> <p>Ensure paths are kept clear of boats and equipment, boats are not to be left at the top or bottom of the steps leading to/from the riverbank. Event officials to enforce or move boats as appropriate.</p>

First Aid Provision	All	3	3	At least one qualified event First Aider will be appointed for the event. First Aid Kit kept in control Check prior to the event. Organiser to advise of any equipment used. First aid to be summoned via control - First Aid information to be included in event information and notices displayed at the event. Emergency Plan covers summoning emergency services and/or directing people to local hospitals.
Event notices / information – advising paddlers of hazards	All	1	2	Organiser to ensure that required / relevant safety notices are displayed at race control and if required by the river access and by finish. Any notable hazards around access, egress or along the length of the course will be highlighted at the event briefing.
Liability Insurance	All	1	5	Kayak Northumbria, on behalf of Wild Water Racing Committee, as part of a Paddle UK affiliated club hold a £10 million third party liability insurance.
Canoeing / Water Related Activity				
Carrying kayaks / canoes	Paddlers, Spectators, Officials	2	2	Paddlers are familiar with appropriate manual handling for carrying their equipment. Juniors to be assisted as appropriate by coaches / parents.
Carrying of boats up the steep rocks at the get out	Paddlers	2	3	Communication will advise paddlers to help each other up the rocks when exiting the river.

Paddling – capsize during race runs	Paddlers	3	2	<p>All paddlers are notified that Canoeing is an ‘assumed risk sport’ both on completing entry and by notices displayed.</p> <p>All paddlers to wear appropriate protective equipment including Buoyancy Aid and helmet as per WWR rules.</p> <p>Paddlers to be reminded of the requirement to stay on the water and provide safety after their runs until the next two boats are finished in event briefing.</p> <p>Race runs to be organised so there are adequate gaps between paddlers.</p> <p>Paddlers will be reminded at the briefing that it is a requirement to help any other paddler who is in distress during the race.</p>
Paddling – capsize during ‘free’ practice	Paddlers	3	3	<p>Paddlers / parents / coaches to be made aware in event information that they are responsible for their own safety during free practice.</p>
Being struck by other paddlers equipment on the water (Boat / Paddle)	Paddlers	2	3	<p>All paddlers are notified that Canoeing is an ‘assumed risk sport’ both on completing entry and by notices displayed.</p> <p>All paddlers to wear appropriate protective equipment including Buoyancy Aid and helmet.</p> <p>Start intervals as per WWR rules to minimise the possibility of paddlers colliding.</p>
Pinning on rocks, trees or bank	Paddlers	2	4	<p>Course to be planned to minimise potential of pinning.</p> <p>Tree branches that have fallen into the race course to be removed before racing.</p> <p>All paddlers are notified that Canoeing is an ‘assumed risk sport’ both on completing entry and by notices displayed.</p> <p>Any specific pinning hazards will be highlighted at the event briefing.</p>

Hazard	Who might be harmed	Likelihood (1=Low, 5=High)	Severity (1=Low, 5=High)	Control measures
Hypothermia	Paddlers	2	4	<p>All paddlers to wear usual protective clothing / equipment for slalom paddling appropriate to the conditions / weather. To include Buoyancy Aid and helmet.</p> <p>First Aid kit to include suitable equipment to treat condition.</p> <p>Qualified First Aiders at the event.</p>
Leptospirosis (Weil's Disease)	Paddlers	2	4	<p>All paddlers to be aware of the risk and follow standard practice of covering cuts etc, and that Canoeing is an 'assumed risk sport' on event information and notices.</p> <p>As this is a natural river it is advised that all paddlers wash hands / face between paddling & eating.</p> <p>As per WWR rules, all paddlers must wear closed-toe footwear. This will reduce the likelihood of any small cuts to feet.</p>
