Langham Farm Slalom- Event Safety Plan

The Event: Langham Farm Slaloms are ranking division 3 and 4 events to be held during 2025

Location: The site is at Langham Farm near Rode, approximately 6 miles from Frome. Access from the main road at Rode is half a mile down the farm track, turning sharp left in front of the farm house. The site is in two fields, split and bounded by the river Frome and a disused mill stream. Parking is in the first field, the slalom course and camping is in the second field. The site is accessed by driving across a bridge over the mill stream next to the farm house. From one end of the site to the other is approximately 250m.

Slalom Course: The start is next to a weir which is usually dry in summer. The first part of the course follows the route of the mill stream and walls have been built out from the banks to create eddies. The course then flows sharp left under a bridge into a pool below and finishes with a short flat upstream section of the river. Continuing upstream, it is an easy paddle back to the weir.

Facilities: There are flush toilets on site in the parking field, these have been installed approximately 40cm above ground leve to reduce the flood risk, plastic steps or paving slabs on blocks are used a steps to aid access. A marquee will be set up in the parking field for hot food and drinks. A container type portable office is used as "Control". General communication from Control is through a PA system, communication to starter/finisher is via TUTTI.

Water Safety: At normal water levels there is low flow down the course. A minimum of one bank based person will be located next to the bridge, with throwline and ready to wade into the river. Most parts of the river can be waded with little difficulty. Below the bridge (at the bottom of the course) there is flat water which makes recovery of paddlers and equipment easy.

First Aid provision: A qualified first aider will be on site throughout the event, a first aid kit is available in the storage container. The nearest defibrillator is at Rode Village Hall which is about 800m form site and accessed via the farm track. The nearest minor injuries unit is approximately 4 miles away. Mobile phone signal can be patchy but can usually be obtained in the bridge area, most of the time the landline phone at the farm house can be accessed if needed. A vehicle will be positioned so that it can be easily used to go and get emergency help or take a casualty to get help
